If Owner does **not** follow the above rules and regulations, the Owner shall accept full and complete legal responsibility and liability for any personal injury or property damage incurred by any party and shall, in all ways, hold the Association and its members, officers, directors employees and agents harmless from such legal liability and damage, if any. Further, this agreement is binding on the heirs, assignees, transferees of the parties hereto including, but not limited to any subsequent Owner. Owner shall also be responsible to maintain all improved areas in a first class condition so as to preserve the beauty, quality and value of all property in Lake of the Woods. Otherwise, Owner will be required to remove any improvement or substance applied at Owner's expense.*
