**AMENDMENT TO THE
BYLAWS
OF
THE LAKES OF JACARANDA HOMEOWNERS ASSOCIATION, INC.
(the "Association")**

This Amendment (the "Amendment") to the Bylaws of The Lakes of Jacaranda Homeowners Association, Inc is made by TAYLOR WOODROW COMMUNITIES, a Florida general partnership ("Declarant") effective this 28th day of March, 2000

WITNESSETH

WHEREAS, on August 11, 1993, Declarant executed the Declaration of Covenants and Restrictions for The Lakes of Jacaranda (the "Declaration") recorded in Official Records Book 2555 at Page 1764 et seq., of Sarasota County, Florida. The Articles of Incorporation and Bylaws of the Association are attached as Exhibits C and D, respectively, to the Declaration.

WHEREAS, pursuant to Article XIV of the Articles, prior to turnover, the Declarant is entitled to unilaterally amend the Bylaws; and

WHEREAS, Declarant now desires to amend the Bylaws regarding number of Directors.

NOW, THEREFORE, for good and valuable consideration, receipt of which hereby acknowledged, Declarant hereby amends the Bylaws as follows:

Article IV, Section A of the By-laws of The Lakes of Jacaranda Homeowners Association, Inc shall be amended to read as follows

"A The Articles of Incorporation control the election, minimum and maximum number and qualification of the Board of Directors. The number of Directors shall be designated and increased or decreased by resolution of the Memberships from time to time; provided, however, that during the time that Declarant has the right to appoint a majority of the Directors, the number of Directors shall be designated, increased or decreased from time to time by Declarant giving written notice to the Board establishing the number of Directors."
