

**MINUTES OF THE MEETING
BOARD OF DIRECTORS
LAKE OF THE WOODS OF JACARANDA HOMEOWNERS ASSOCIATION, INC.
TUESDAY, MARCH 2, 2010
1:30 P. M.**

Present: Joe Beima, President, Matt Soldano, Vice President, Bill Meints, Treasurer, (via telephone conference call), Beverly Weltzien, Secretary, Guy Cusumano, Director, Jim Kraut for Management and owners in the audience.

The meeting was called to order by the President, Joe Beima at 1:35 P. M. at the clubhouse. Roll was called and a quorum was established. Proof of Notice of Meeting was announced, with Notice and Agenda posted at least forty-eight hours in advance. All motions passed at this meeting were unanimously approved by all Directors present, unless otherwise noted.

Comments from Homeowners: 1). Judie Gollwitzer gave her newsletter report, which included having a lecture series at the clubhouse, a cooking demonstration on April 24, and she reminded the Board that newsletter articles are due now. 2). Barbara Hockett stated that there was poor lighting at the South entrance, and suggested the Board look at the new light posts at the golf course on the South end of Venice East Blvd. She is still waiting to get some lawn signs notifying owners to stay out of a particular area and stated that she had done a records review of the annual meeting ballots and envelopes. 3). Greg Fahey questioned legal expenses on various dates and requested that the Board provide him with a copy of the minutes of April 17, 2007. 4). Warren Major questioned the Association's enforcement practices. 5). It was suggested that the Board have date of drivethru and person making the observation on the enforcement letters that go out to all owners. 6). Lisa Kirk stated that the Board had violated the covenants concerning her recent records inspection request. 7). Denise Sudia reviewed various charges to the Association's attorney.
